In addition to being used as a place to serve patients, these areas became a facility that provided medical education and housed students. In addition, libraries containing a large number of books were established and scientific discussions were held, these spaces also served as a center for the exchange of knowledge and experience of judges and students. All opportunities have been created for doctors to receive good medical education and develop their profession. In fact, special funds have been allocated so that doctors can have a good standard of living. These medical
