In our country, the "Convention on the rights of the child" was ratified on December 9, 1992. Our state undertakes to protect all the rights of children recorded in this international document, including physical, mental and sexual violence, torture or treatment in other forms of cruelty, gross or degrading human dignity.

The law of the Republic of Uzbekistan "on guarantees of the rights of the Child" defines as one of the main directions of the state policy on the protection of the rights of the child to protect the life and health of the child, prevent discrimination of the child, protect the honor and dignity of the child, ensure equality of the rights and(Article 4)²⁰⁸

At the same time, in this law, the state must take the necessary measures to ensure that the child is protected from discrimination of all forms, each child has the right to protection from encroachment on his honor and dignity, from unlawful interference in his personal life, the state from physical, mental and sexual violence, torture or cruel, rude or it is established that a person carries out protection against the treatment of other forms of degrading dignity.(Article 7)²⁰⁹

There are three main types of child abuse, which are:

- 1.Physical violence,
- 2.Sexual abuse,
- 3.Mental abuse.

Physical abuse can occur between children of both sexes, but it is often common among boys children by causing physical damage from themselves to adults through which their psyche is broken. Children and girls of adolescent age meet for sexual abuse. If the children who have fallen into this state are not mentally supported, in the future they will remain a mail to the suisit, such children should be given atrogynous explanations on the mountain of the holiness of life.

Mental abuse is considered the most common type of violence when children are not given enough attention from their parents, not counting on their interests, not respecting their decisions lead to mental disorders in children.

Children grow up with deviant behavior if the later stages of violence are not sufficiently rehabilitated. Deviant behavior-deviant behavior (deviant, lat. deviatio-

The main forms of Deviant behavior include delinquency, including crime, drunkenness, drug addiction, prostitution, and suicide. There is an inextricable link between the development of deviant behavior among the younger generation, reaching maturity, and the growth of crime phenomena in society day by day. The desire to commit illegal actions is increasing with the development of deviant behavior of children and adolescents. The main reason for the formation of Deviant behavior is the intensification of Zamo, the inability to accept economic inequality, mass globalization, free access to information, migration, child expropriation, the development of democracy, as well as social phenomena often cause negative reactions in the adolescent environment. Deviant behavior depends on social, biological and psychological factors that must be taken into account when educating young people. In a society with a whole head in general in children, the deviation in the minds of children is a big problem, focusing on these problems, we feel that the crises that occur in different periods of children's life become important in their subsequent life, in finding enough place in society. It is during these crises that children will be able to find their place in life in the future if they receive enough attention and enough affection. Eric Erickson, creator of ego - personality theory, identified 8 stages of psychosocial personality development. As a result of changes in the age of the child in these 8 Stages, various psychedelic disorders arise in him. At the third stage of psychosocial development (3-6 years), a psychological crisis is accompanied by the formation of feelings of guilt, self-denial and futility, which can subsequently lead to addiction, giftedness or fraud, personality disorders.²¹⁰ Also B.M.Miller notes that for a preschool child, the concept of "death" is determined by the loss of the mother, and this often causes their unconscious fears and worries. The fear of parental death in mentally healthy preschool children was observed in 53% of boys and 61% of girls. Fear of one's own death was recorded in 47 percent of boys and 70 percent of girls. Suicide cases are rare in children under 5 years of age, but there has been a tendency for them to grow in the last decade. Today there are women who have experienced family violence families in the families of children who have grown up, the developmental coefissience of
